The EU sustainable cocoa initiative

The European Union is the world's largest cocoa importer accounting for 60 percent of world's imports, with beans originating mainly from Côte d'Ivoire (the world's largest producer), Ghana and Cameroon. These three countries benefit from free trade agreements with the EU, referred to as Economic Partnership Agreements (EPAs), which among others, allows for duty free and quota free exports of cocoa to the EU. Nevertheless, the cocoa value chains in these countries are facing many interlinked challenges in terms of sustainability, which include persistent poverty of small producers, child labour and deforestation.

On 22 September 2020, the European Commission launched an inclusive dialogue on sustainable cocoa production in Côte d'Ivoire and Ghana. The dialogue brought together key EU stakeholders, including representatives of Member States, the European Parliament, industry and civil society organisations, and the authorities and Ambassadors of the Republic of Côte d'Ivoire and Ghana. The objective of the multistakeholder dialogue is to foster progress in ensuring a living income for cocoa farmers, to reduce child labour and to enhance the protection and restoration of forests in cocoa-producing regions.

Under the Sustainable Cocoa Initiative, the European Commission organised eight thematic roundtables of the multi-stakeholder *Cocoa Talks* on living income for farmers, standards, traceability with respect to child labour and deforestation, regulation with a focus on due diligence, sustainable production of cocoa, development cooperation and finance, and the role of EU consumers.

The Sustainable Cocoa Initiative supplements EU legislation on corporate sustainability due diligence and on tackling global deforestation associated with the EU's consumption footprint. In parallel to the Brussels-led Cocoa Talks, a series of similar national dialogues have been organised by the EU Delegations in Ghana and Côte d'Ivoire and in Cameroon.

In June 2022, this dialogue culminated with the adoption of a Roadmap of Action points to deliver against the objectives of sustainable cocoa and trade. The EU Sustainable Cocoa Initiative is also supported by a far-reaching EUR 25 million programme "EU sustainable cocoa programme" (SCP) that started in 2022 in Côte d'Ivoire, in Ghana and in Cameroon, and that is co-funded by the German development cooperation (BmZ).
